

**LEGAL NOTICE**  
**NOTICE OF GENERAL ELECTION<sup>1</sup>**

Notice is hereby given that the City of Belle Glade, Florida, will hold a General Election on Tuesday, March 13, 2018, between the hours of 7:00 a.m. and 7:00 p.m. for the purpose of electing three commissioners, each for a term of three (3) years. There will be one commissioner elected to represent one of the following Seats: "C", "D", and "E". Candidates must be a qualified elector of the City of Belle Glade for at least six (6) months prior to the beginning of qualifying.

The first day for qualifying begins November 21, 2017, at noon, and the final day for qualifying is November 28, 2017, at noon. Candidates must file in person with the City Clerk at City Hall, 110 Dr. Martin Luther King, Jr. Blvd., West, Belle Glade, Florida, during regular office hours (Monday through Thursday, 7:30 a.m. to 6:30 p.m.) until said date and time. Each candidate shall be voted upon by the electorate at large.

Registered voters in Precincts 6022, 6024, 6028, 6029, 6032, and 6036 are qualified to vote in this election. To qualify as a registered voter for this General Election, you must register with the Palm Beach County Supervisor of Elections by February 12, 2018.

In the event of a tie vote between the candidates receiving the largest number of votes cast for a seat in the general election a general run-off election will be held on Tuesday, March 27, 2018 between the tied vote candidates for that seat, and the candidate receiving the greatest number of votes cast for that seat shall be declared the winner. To qualify as a registered voter for the run-off election, you must register with the Palm Beach County Supervisor of Elections by February 26, 2018.

In the event of a tie vote between the candidates in the run-off election, a special run-off election shall be called by the city commission within sixty (60) days after the results of the election have been determined.

**AVISO DE ELECCION GENERAL<sup>2</sup>**

Se notifica que la Ciudad de Belle Glade, Florida, llevara a cabo su Elección General el martes, 13 de marzo, 2018, entra las 7:00 a.m. y 7:00 p.m. con el propósito de elegir tres Comisionados, cada uno por un termino de tres (3) años. Se elegirá un comisionado que representara los Cargos: "C" "D" y "E". Los candidatos deben ser electores calificados de la Ciudad de Belle Glade por al menos seis (6) antes del comienzo de la calificación.

El primer día de calificación comenzara el 21 de noviembre, 2017, a las 12:00 p.m., y el ultima día de calificación será el 28 de noviembre, 2017, al mediodía. Los candidatos deben registrarse en persona con la Secretaria de la Ciudad en el Ayuntamiento de la Ciudad, 110 Dr. Martin Luther King, Jr. Blvd., West, Belle Glade, Florida, durante las horas regulares de oficina (Lunes a Jueves, desde las 7:30 a.m. a las 6:30 p.m.) hasta la fecha y hora dicha. Cada candidato será elegido por los electores en general.

Los votantes registrados en los Precintos 6022, 6024, 6028, 6029, 6032, y 6036 están calificados para votar en esta elección. Para calificar como votante registrado para este Elección General, usted deberá registrarse con el Supervisor de Elecciones de Condado Palm Beach para el 12 de febrero, 2018.

En caso de empate entre los candidatos que reciban la mayor cantidad de votos para uno de los cargos en la elección general, una elección de desempate se llevara a cabo el martes, 27 de marzo, 2018, entre los candidatos con la mayoría de votos para un cargo en particular. Para calificar como votante registrado para la Elección de Desempate, usted debe registrarse con el Supervisor de Elecciones del Palm Beach para el 26 de febrero, 2018.

En caso de empate entre los candidatos durante la Elección de Desempate, una Elección Especial de Desempate será realizada por la Comisión de la Ciudad dentro de sesenta (60) días después de que los resultados de la elección se han determinado.
